

PUBLICATIONS AND SUBSCRIPTION SERVICES AVAILABLE FROM THE AUSTRALIAN INDUSTRIAL REGISTRY

The Australian Industrial Registry publishes the decisions, awards and orders (approximately 6,000 documents each year) made by the Australian Industrial Relations Commission pursuant to the *Workplace Relations Act 1996*. These documents are available for purchase through the Registry in the capital city of each State and Territory.

The Australian Industrial Registry also publishes various reference documents, such as awards and agreements lists and industry panels lists.

The following subscription services are available from the Principal Registry:

Specified Awards Service [Code E]

- One copy of all variations and decisions relating to a specific award.
- Posted as variations and decisions are published.
- COST = \$10 per award per annum *PLUS* an initial joining fee* based on the number of documents required to provide an up-to-date copy of the award.

Loose-leaf Awards Service [Code H]

- One copy of a specified award in an up-to-date consolidated loose-leaf format.
- Posted as replacement pages amending awards are published.
- COST = \$15 per award per annum *PLUS* an initial joining fee* based on the number of pages in the award.

AIR Bulletin Service [Code G]

- One copy of the Australian Industrial Registry Bulletin including weekly decisions summaries, details of procedural changes and developments in the Registry and advice regarding the rights and obligations of organisations registered under the Act.
- Posted weekly.
- COST = \$150 per annum.

** Joining fee is dependant on the number of pages/documents involved in providing an up-to-date award. Contact your local Registry for the exact cost.*

Reference Documents Service [Code D]

- One copy of awards and agreements lists and supplements, industry panels lists and reference documents.
- Posted as documents are published.
- COST = \$130 per annum.

Decisions Service [Code C]

- One copy of all decisions, awards lists including supplements, industry panels lists and reference documents.
- Posted weekly. Each despatch contains a packing slip detailing the items included and their cost.
- COST = Approximately \$1,000 per quarter. The face value of material received *LESS* a 20% discount, *PLUS* postage, is debited weekly from the subscriber's account.

The amount to be paid in advance at the beginning of each quarter may vary depending on the general volume of material being published.

Awards and Decisions Service [Code B]

- One copy of all awards, orders, decisions, awards lists, industry panels lists and reference documents.
- Posted weekly. Each despatch contains a packing slip detailing the items included and their cost.
- COST = Approximately \$2,000 per quarter. The face value of material received *LESS* a 20% discount, *PLUS* postage, is debited weekly from the subscriber's account.

The amount to be paid in advance at the beginning of each quarter may vary depending on the general volume of material being published.
